

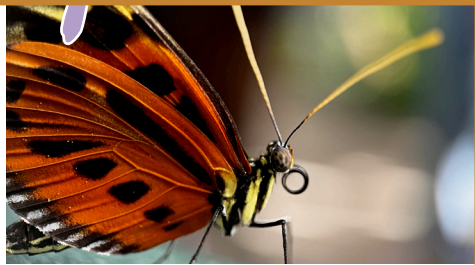

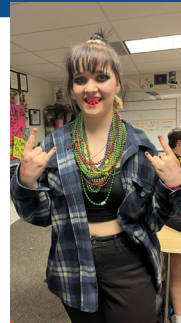
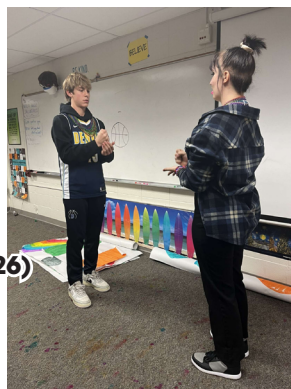


RO-SHAM-BO

At the state meet, the number one team finished 12th, the second highest finish of any BHS Mock Trial team. 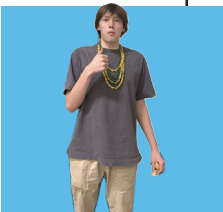
